of their deaths leaving issue

Item Second I Request that my debts be paid that my body
have a decent burial my funeral expenses & doctor
be paid out of my personal property and that the remain-
der of my personal property be used for the support
and maintenance of my said wife and six children
of predecease & I request that my mother in law she
being my step mother A M Aldridge have a
home with my said wife & children during the life
of the said M M Aldridge provided she remains
single

Item Third I Request that in the event my said wife
should again marry that my testator hereafter
named take charge of & be the above described
fund to the best interest of my said children

Item Fourth I hereby constitute and appoint my
friend J S Wood executor of this my last
will and testament this June 4th 1872
