I, Alvin Reynolds of the County and State aforesaid being of sound mind and disposing memory do hereby make declare and publish

this written instrument as my last Will and testament hereby revoking all Wills and Codicils thereto heretofore made by me. Item 1st I give and bequeath my body to the earth and my soul to God, who gave it.

Item 2nd After the payment of all of my just debts it is my will and desire that the whole of my estate both real and personal be disposed of as herein after directed.

Item 3rd It is my Will and desire and I hereby give and bequeath to my beloved wife Berthian Reynolds at my death the right title possession and Control of Lot of Land Number One Hundred and Thirteen (113) in the fifth District of Harris County Containing Two Hundred two and a half acres more or less She to have use and Control the same for the object and purpose of having a home during her lifetime and to have the rents and profits of said Land as long as she may live, and at her death this Lot of Land is to revert and become a part of my estate and is to be disposed of by my executor in like manner as herein after directed, as to the balance of my Estate -

Item 4th It is my will and desire and I do hereby direct my Executor that as soon after my death as he may think practicable that he shall proceed by Sale or by Lot to divide my whole estate into seven parts equally representing the seven legacies, and when so divided and reduced into money or otherwise what he can make division he shall pay out to all my children or their legal representations equally share and share alike, the child or children of any of my children deceased to represent the share of their Father and Mother.

Item 5th It is my Will and desire and I do hereby direct that the provisions in the fourth Item of this my Will shall not interfere with the provisions of the third Item of this Will nor a deed of gift heretofore made by me and dated the third day of October AD 1890 and recorded November the 24th 1890, but as soon after the death of my wife as executor shall think practicable, he shall proceed by Sale either private or public as he may think best to dispose of Lot of Land No 113 in the 5th District of said County and pay it out as directed in Item fourth -

Item 6th It is my Will and desire and I do hereby direct that my executor shall use his discretion in the disposition of my whole property as well real as personal property to sell the same either private or public without any order of any Court and I hereby direct that he may either probate this Will or not as he may choose that he may sell any of my real estate according to the provisions of this Will and may give and warrant titles to the same without the probate of this Will.

Item 7th I hereby nominate and appoint my beloved Son Jot Reynolds Executor of this my last Will and testament hoping and believing that he will execute the same -
