and George P Combs my Executors for the use and
support of my daughter Elizabeth Elkins during
her life at her death to be equally divided between the
heirs of her body to wit the said James and twenty five
acres of land it being the place whereon Garret & his
now live also one bed and furniture

Item the 3rd I will to my daughter Prudence Parley
five Dollars in money

Item 4th I will to Martha Sarah Pulling five
Dollars in money that is my Granddaughter of J Josiah
Combs

Item 5th I will that all my Just debt be paid and
after paying all my debt that all the remainder of my
description of my Estate be equally divided between
my son James B Garrett and my daughter Caroline
Combs and my Granddaughter Amelia Clark

Item 6th I hereby nominate and appoint upon James B Garrett
and George P Combs my son in law of the state aforesaid James
B Garrett of the County of Wadsworth and George P Combs
of the County Henry and state aforesaid my lawfull
Executors to this my last will and testament hereby reposit-
ing all of other wills heretofore made by me in testa-
mentary when of I have hereunto set my hand and affixed
my seal this fourth day of August in the year of our
Lord one thousand eight hundred and forty nine
