 Item second I desire and direct that all my just debts be
 paid without delay by my Executor hereinafter named as
 I am unwilling my creditors should be delayed of their
 Rights especially as there is no necessity for delay
 Item third— I give and bequeath to my son Aaron Roper
 my youngest child (Boy) Martha M Roper Mary Ann
 E Roper John A Roper Isaac Roper Charlotte Roper and
 William M Roper the land whereon I now live it being the
 East half of Lot number one hundred and sixty three (163)
 in the Second District of Henry County and containing one
 hundred and one fourth (101 1/4) acres be the same more or less
 with all the rights members & appertinances to said Land in
 any wise appertaining and belonging together with my
 stock of all kinds household and kitchen furniture to be
 managed by my son Aaron Roper or his legal Representative

and to be a common home for my dow his wife and the above
named six children so long as they live single or till the
youngest becomes of lawful age and then to be sold and
the proceeds equally divided between the above named six
children

Item Fourth - I give and bequeath to the heirs of my son Moses
Roper deceased one dollar he having had his part heretofore

Item Fifth - I give and bequeath to my daughter
Sarah Hicks one dollar she having had her part heretofore

Item Sixth - I give and bequeath to my daughter Levina
Binson Jones one dollar she having had her part heretofore

Item Seventh - I constitute and appoint my beloved son
Aaron Roper Executor of this my last will and Testament
this 38th day of August in the year of our Lord 1849
