Georgia } On the name of God Amen. The fourth
Henry County } day of April in the year of our Lord
One thousand eight hundred and thirty four.
I Jesse Bowden of the State & County aforesaid Calling To
Mind that it is appointed for Man Once To die and I
Being affected in body - but of sound mind & memory do
make this my Last will & Testament in manner and form
following. first of all I recommend my soul To god who gave
it. and my body To be buried at the discretion of my Executors
here in after named
1st The Land where on I live is To be sold also the negro
man George. and every other species of property that I am
possessed with except the property here in after named.
My Children James M. William F. Andrew J. Elizabeth
Mary. & Charles. Bowden are To have such household
furniture as I have given To my daughter Martha
Adamson heretofore and such other property as I have
To my daughter Martha is To be had and the above
named Children To be made Equal with money - after my
Beloved wife Sally. has taken out such household and kitchen
furniture together with such cattle and hogs - as she may
want also the Black mare then the remaining property
To be sold (viz) all the perishable property and this
Equally. Divided among. all my Children
The money. that the Land and negro George sell for my
Beloved wife Sally is To have the use of. During her widow-
hood or Life Time and at her marriage or death this money
is To be divided. Equal among. my Children or their heirs
except my son Charles. Bowden and provided he stays
with and takes care of his mother during her Life at his
Death he Charles. Bowden is To have of that money. the
Land and George brings as much as any. Two of my other
Children Lastly I desire that all my Just debts be
paid and that what money. I have in hand and what
notes I have my wife Sally. is To have the use of. To buy
her Land and other articles To live on I nominate and
appoint my Beloved wife Sally. Executor To this my Last
will and Testament In witness whereof. I have hereunto
set my hand and affixed my seal To this my Last will and
Testament the day and year just above written
