Item 1st } I have given to my children James Cash Moses
Cash Stephen Cash & Lucy Cash after words Lucy White
& now dead at such times as suited them & my own convenience
all the property which I intended they should have out of my
Estate they are therefore to have no more but the balance
of my property I give to my daughter Mary Lane & Pally
now living with me as follows

2^d I Give my said daughters all the property both real and personal of which I am now possessed or in any manner claim little to an interest in consisting of the entire tract on which I now live & two lots of land drawn by me in the late land lottery of the State of Georgia believed to be lots 88 nine hundred & fifty three in the 3^d dist & second section in Land and lots 88 44 in the seventh dist fourth section of the Gold Region of Cherokee County also a negro woman named Lane and her children & such other & all the personal property in my possession

Item 3^d I will that my wife Lucy shall remain with my said three daughters & be supported from the property herein bequeathed

Item 4 I will that my lands in Cherokee drawn in the lottery aforesaid be sold as soon as convenient & prudently having regard to value & the money appropriated as my said daughters shall desire for their mutual benefit

Item 5th I will that all my last debts be paid

Item 6 - I will that my daughters select a person as their agent to act in selling the land in Cherokee

Item 1st " Should I draw any pension as a Soldier in the Revolution

It is to be Subject to this my Will and to be disposed of
as afore said

Item 8th I will that no Inventory & appraisement be made of my
property and I freely constitute and appoint the Revueit
James Lumbly my Executor for the sole purpose & no other
than proving proving this my last will & Testament
and having the same admitted to Record in Testimony whereof
I have here unto seth my hand & affixed my Seal on this the
Twelfth day August 1833 signed seal & acknowledged
