

In the name of God, Amen.

I John Dorsey of the County of Henry and State of Georgia being of sound and disposing mind and memory and being desirous to settle my worldly affairs while I have strength so to do, do make and publish this my last will and testament, hereby revoking all wills by me at any time heretofore made:

And first I commit my soul to God who gave it and my body I desire to be buried in a christian like manner - And my worldly estate I dispose of as follows:

First, I give and bequeath to my wife Evaline one lot of land containing two hundred two and one half acres No 162 in the 6th District of Henry County and known as my home place whereon I now live, together with all the stock and farming tools and provisions that may be upon the place at my death, to have and to hold said property during her natural life and after her death I desire all of the above described property to go to my son S. G. Dorsey in fee simple.

I also give to my beloved wife one bed and bed-clothes and all other household furniture that has accumulated since my intermarrying with the said Evaline, and also the family carriage. The above named property both real and personal, I bequeath to my wife expressly in lieu of dower and is all I desire her to have of my estate.

Item 2nd I give and bequeath to the children of my deceased son John M. Dorsey and to S. D. Dorsey and Isham Dorsey the notes which I now hold against John M. Dorsey and Isham Dorsey and S. D. Dorsey share and share alike; that is to say, to the children of John M. Dorsey one third of said notes and to S. D. Dorsey one third and to Isham Dorsey the remaining third; the aggregate of said notes to be ascer-

lained and divided as above stated.

Item 3rd I give and bequeath to my son Irha Dorsey one lot of land situate and lying in the 15th District of Lee County, Ga. containing two hundred two and one half acres known as lot No. Eighty one (81) in said District.

Item 4th I give and bequeath to my two daughters Alie Crawford and Martha Johnson two beds & bed-clothing and other household furniture which was the property of my first wife. And I further give to my two said daughters three hundred acres of land the same being in the 6th Dist of Henry County and adjoining the lands of Thos. S. Crawford and Mr Peeples. Said Alie and Martha are to be equal in the property mentioned in said fourth Item.

Item 5th I give and bequeath to Alie Crawford wife of Thos. S. Crawford one note dated December 2nd 1857 and due twelve months thereafter for Eleven hundred dollars and signed by W. H. Glenn and Thos. S. Crawford secty. upon which note suit is now pending in Henry Superior Court. The above note I give as aforesaid upon the condition that when suit is withdrawn by me said Thos. S. Crawford is to pay all costs that may have accrued in the prosecution of said suit now pending against him.

Item 6th I give and bequeath to my son S. G. Dorsey one lot of land in the 6th district of Henry County containing two hundred two and one half acres, and bounded by the land of Thos. S. Crawford, and by the land of S. G. Dorsey and by the land of Henry Crawford and the lands known as the Nash lands.

Item 7th I nominate and appoint my son S. G. Dorsey Executor to execute and carry out the provisions of this my last will and testament.

I John Wade, a citizen of the County of Henry, and State
of Georgia, now in the eighty sixth year of my age, and in (as I
feel and have good hope to believe) the fifty sixth year of my Chris-
tian pilgrimage; infirm in body, thought, and mind, do make and
declare this instrument, which is written fully and verbally to
my directions to be my last Will and Testament, revoking all other

Wills. It is my desire, and I do hereby direct, that
when this state of existence is ended, with me, that I be interred in a
manner as plain as is consistent and practicable.

Item. To my dear, beloved wife Rachel Wade, I give and be-
queath, the use, profit and benefit of my whole Estate, real &
personal, for the term of her natural life, to be used and man-
aged during such period, as her judgement may dictate.

Item. Upon the decease of my wife, if it is my desire, that
my estate, real and personal (for the term of her natural life) be
equally divided among my children, except such parts thereof
as are hereinafter specified and bequeathed.

Item. In testimony of my sense of his attachment to
me, and for his faithful services during my afflictions, as well
as those of my family, and for and consideration (as I regard
it) I do hereby bequeath, to him of the proceeds hereto attached
