family that I should make a disposition of the property

therefore make this my last will & testament
hereby revoking & annulling all others by me here-
before made.

Item 1st I give devise & bequeath to my son James Clark
fifty acres of land on the south side of lot & land
ninety eight (98) running east & west across said
lot of land, said lot of land being in the twelfth
(12th) land district of said Houston Co. Ga.

Item 2nd I give devise & bequeath to my daughter Sarah Brown
fifty acres (50) of land of said lot & land ninety eight
(98) which is north of the fifty acres that I have
in item first devised to my said son James, which
said fifty acres hereby devised to my said daughter
Sarah runs east & west & is in said twelfth (12th)
district of said Houston Co. Ga.

(50) acres of land of said lot number ninety eight
which runs north & south on the east side of said

I give devise & bequeath to my daughter Harriet Leback

which runs north & south same being in said 12th Dist
lot No 98 except the one hundred & fifty acres dis-
posed in items 1, 2 & 3 in this will.

I give devise & bequeath to my son Robert Leback fifty
acres of land of lot of land number fifty seven (57)
which runs east & west & is directly south of that fifty
acres of land on said lot hereinafter devised to my daughter
Georgia said land being in said 12th District of Houston
Co. Ga.

I give devise & bequeath to my daughter Georgian
fifty acres of lot of land No 57 said fifty acres runs
east & west & is on the north side of said lot of land No
57 in 12th Dist of Houston Co. Ga.

I give devise & bequeath to my daughter Carrie Leback
fifty acres of land on lot No fifty six (56) which said
fifty acres runs north & south & is located west of Robert
Leback's home house same being in twelfth (12th) District
of said Houston Co. Ga. The home house on this fifty acres
is to be removed from off the same & placed upon the
fifty acres immediately west for the benefit of my
daughter Tilly.

I give devise & bequeath to my daughter Tilly Leback
fifty acres of land on said lot No 56 which runs
north & south on west side of said lot No 56 & being
in 12th Dist of said Houston Co. Ga.

I give devise & bequeath to my son John Leback fifty
acres of land on lot number seventy one (71) said fifty
acres runs east & west on the north side of said lot
No 71 & is known as a portion of the home house lot of
land same being in twelfth (12th) Dist of Houston Co. Ga.

I give devise & bequeath to my son Bryant Leback
fifty acres of land of lot number seventy one (71) which
runs east & west & is immediately south of that fifty
acres hereinbefore devised to my son John same
being in 12th Dist of said Houston Co. Ga.

I give devise & bequeath to my daughter Mattie

said fifty feet square is hereby devised to the heirs
of said school upon which a school house is
now located. This provision to my said wife is made
expressly in lieu of dower & twelve months support.

Item 13th All of my personal property of every description
I hereby give & bequeath to my wife Lelia & my
sons Bryant & John & my daughters Harriet &
Matthie they being give in full & to share equally
in the division of said personal property that
I shall die seized & possessed of.

Item 14th I give & devise to my son Thomas the sum
of five dollars & the reason why I give him
down in this my last will & testament is that
I have already advanced to him a sum of money
that will equal if not exceed the property herein
given devised & bequeathed to the other members
of my family.

Item 15th I do hereby appoint my wife Lelia & my two
sons Robert & Bryant the executors & executors of
this my last will & testament. April 22nd 1895
