 Jackson County of the County & State of Georgia Do hereby make this my
 last will & testament in witness whereof I have signed my hand & seal
 to be bound in a Christian like manner at the City of My State I desire
 following to my first Wife Elizabeth Stockton I leave one Dollar
 and to her Children one Dollar to each Child and no more my Estate
 to Eliza like I leave one Dollar & no more to my son James M
 Stockton I to him all my Land on the South side of the main Road
 leading by my Dwelling being the Land whereon I now live & a Negro
 Boy by the name of Henry to my Daughter Mary Ann Stockton I
 leave all my Land on the North side of the Road being a part of the
 same Land that I have given to my dear friends & one Negro Girl named
 Susan & a good young horse of Common quality to Elizabeth Blair and
 to Margaret Gibson & to Martha Child & to Sarah M Duffen Worton
 My Wife Sarah Stockton I leave jointly to them as follows five or
 six Negro Women full a man Hannah a woman Isaac a Boy & all my stock to
 be divided Equally among them if they can't agree it is to be legally sold
 & the Money Equally divided & it is further provided that the Money or the Part
 of it that may come to my wife Sarah Stockton at my Death shall be
 divided amongst the Children that I have had by her at her Decease first
 going to Benjamin Abner Stockton one Hundred Dollars and it is further
 provided that my wife Sarah Stockton is to have her Support of the Land
 that I now live on & all the Hays had & to be furnished to do as she
 thinks proper with & it is further provided that if Hannah should have any
 Child or Children such Child or Children is to be Equally divided amongst James
 M Stockton Margaret Gibson Elizabeth Blair Martha Child Sarah M Duffen
 Worton & Henry Ann Stockton by consent or Sale as they may think best
 and it is further provided that I have one Acre of Land No 713 in 4 District
 of the first Section when drawn near Sampson County & should I have
 any Money by me or Notes or accounts for Money the above Acre of Land &
 Money is to be Equally divided amongst the last named Children
 and I do hereby appoint James M Stockton & Thomas J. Child my Executors
 to this my last will & Testament to carry the same into Effect at my Death
 Declaring all former wills void & of no Effect
