2nd I Give & bequeath to my Daughter Lucinda
Lord twenty Acres of land more or less to bound as
follows to begin at a Rock + 3. at the branch + at
the mouth of the Gully below my old house & pass said
Gully to a pine tree then + 3. thence a north westerly direc-
tion to the old road & along the road to a post oak + 3.
on the original line of said tract of land then a
long the said line to the Creek then up said Creek to
the beginning Rock + 3. during and her husband
Thomas Lord life then & at their decease it is to go to
my son Ezekiel Anthony & heirs forever

3rd I Give & bequeath unto my son Wade Anthony
all that part of my said tract of land beginning
on a pine + 3. going North - & Anthony & a long &
with his line is a north westerly direction to & a rock
the branch then a westerly course along the said
Wade fence down the branch & to William Murr
line to the original line of the old tract & east-
ward along the line to the beginning + 3.

4th I Give & bequeath unto my son Thomas

 my heirs, I do hereby Order my Executor to sell
 with out advertisement in the public gazette
 7th I do hereby appoint & constitute my two sons
 Thomas Anthony & Wade Anthony my Executors
 of this my last & Testament in Testimony where-
 of I have hereunto set my hand & Seal
