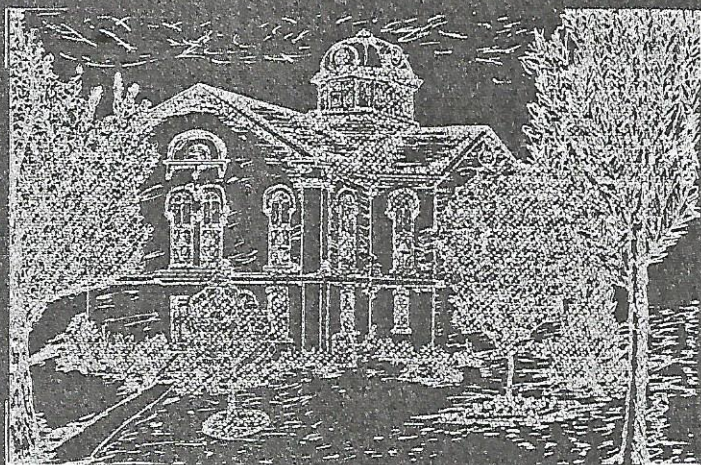

**1803 - 1808**

Bransford, Wm. Strong, Peggy Strong. Witness: John Ramey, Absalom Ramey, J.I.Ct. Recorded Jan. 25, 1808.

Page 616 Jan. 13, 1806, deed from **Gilbert Gay** of Clark County, GA to **John Barnhill** of Jackson County, consideration of \$150 for 80 acres in Jackson County on the Mulberry fork, joining Langley, including the place where Barnhill now lives. Signed: Gilbert Gay. Witness: Joseph Thompson, Junr., Charles Price. Sworn by Joseph Thompson, Junr., on June 27, 1806 before Elisha Winn, J.P. Recorded Jan. 25, 1808.

Page 617 (Power of Attorney) Jan. 7, 1807, Jackson County, I, **David Connally** of Clark County have appointed **Cornelius McCarty** of Jackson County my lawful attorney in fact and do appoint my trusty and well beloved friend my lawful attorney to receive, ask for and demand my part of the estate of **Elijah Christian** deceased in Franklin County, I being one of the legatees ... to dispose of all my rights, interest or claim in said Estate - **William Christian** being administrator of said deceased Estate. Signed: David Connally. Witness: John Harrison, David Witt, J.P. Recorded Jan. 25, 1808.

Page 618 Aug. 21, 1806, deed from **John Lindsay** of Wilks County, GA to **John Carmichael**, consideration of \$355 for 156 acres in Jackson County on the waters of the pond fork of the Oconee River. Signed: Jno. Lindsay. Witness: Wm. Poynor, Middleton Brooks, Jas. Steen, J.P. Recorded Jan. 25, 1808.

Page 619 (Bill of Sale) Dec. 17, 1807, Jackson County, from **Wm. Baird** of Jackson County to **George W. Baird** of aforesaid county, \$150 for 300 bushels of corn, three cows, two white ones and one red one. Signed: William Baird. Witness: Jas. Baird, Alexander Baird. Sworn by James Baird and Alexander Baird on Jan. 6, 1808 before Edw. Adams, J.P. Ex Officio. Recorded Jan. 25, 1808.

Page 620 (Bill of Sale) Dec. 20, 1807, Jackson County, from **William Baird** to **Geo. W. Baird**, both of said county, consideration of \$175 for two stills and vessels, one 75 gallon still and one of 80 gallons, and one waggon. Signed: William Baird. Witness: Jas. Baird, Alexander Baird. Sworn by Jas. Baird and Alexander Baird on Jan. 7, 1807 before Edw. Adams, J.P. Ex O. Recorded Jan. 26, 1808.

Page 621 Dec. 29, 1806, deed from **Anderson Epperson** to **William Baird** late of Abbeville District, SC, \_\_\_\_ (torn) Hundred Dollars for tract of land in Jackson County on Flat creek containing 141-3/4 acres, being part of 287-1/2 acres
