I Rufel Sons of Franklin County, & State of Georgia
do make & declare this to be my last will and Testament
hereby revoking all others. First my will is that my Just
debts be paid. Secondly, I give unto my dear wife Sarah
Sons during her natural life or widowhood, all that part
of the tract of land whereon I now live, and which I pur-
chased of Thomas Minwether, that lies on the North side of
Naked Creek including my Mill thereon, provided she
shall not be permitted to lease, rent or otherwise permit
any one to, cultivate, or otherwise occupy any part thereof.
I further give to my said wife Sarah, during her natural
life or widowhood, one Negro Girl Anick. I further give
unto my said wife during her natural life, one Negro wo-
man named Cady and one negro man named Friday
in terms of a Marriage Contract entered into between
my said wife and myself prior to our intermarriage, the
named Negro Cady is in lieu of Dico, named in said Marri-
age Contract. I further give unto my said wife, during her
natural life, Two Horses worth Fifty dollars Each, two feather
Beds, Bedsteads & furniture, Two Cows & Calves, one Bureau, my
Sideboard & Clock, my Cupboard, one Carding Machine one
third of my Sideboard & Cupboard furniture, Six sitting Chairs,
Six Silver teaspoons, one Common Table, Two Spinning Wheels,
and two small Trunks. Also one third of my Stock of
Hogs, together with a sufficient quantity of Corn & fodder
for her support until she can raise a Crop. I give unto

my said wife Sarah, her heirs & assigns forever, the following Negro
to wit, Peter, Sarah, & her five children, Viz, Adam, Eddy, Aquilla,
Hagar, Joshua & Susan, with their increase. One hundred dollars
in money, one feather bed & furniture. the above and foregoing
property (except that part that is given in perpetuity) at
the expiration of the Term mentioned I bequeath in the same
manner as the rest of my residuary Estate, & I give
and bequeath unto my son Rufus Jones my Negro Man Bob &
his wife Melly, and their children (Viz) Jos. Melly, & Mariah,
Polly, Solomon, Eliza, Bob, Perry & Harbom, together with their
increase. together with one tenth part of the residuary
Legacies herein devised, to my wife; I give and bequeath unto
my son in law Allen Daniel five dollars. I give unto my
Grand Children, Children of my daughters Polly, Daniel. Woin-
ty (except William Daniel) deducting from Oliver Torrells pro-
portion, the sum of Two hundred & forty dollars) one ninth
part of my remaining estate, I give unto my Grand Children,
heirs of Dudley Jones, deceased; One other ninth part of my resi-
duary Estate, out of which said ninth part, I give to the
Illegitimate Daughter of my Grand Daughter Nancy Hop-
er. Four hundred Dollars to remain in the hands of my Exe-
cutors until she shall become of lawful age or marry. -

I give unto my son in law Benjamin Cleveland, one other
ninth part of my residuary Estate, deducting therefrom
the sum of four Hundred dollars. I give unto my six
Grand Children, Children of my Daughter (decd) Amelia
Allen, one other ninth part of my residuary Estate, deduct-
therefrom the sum of seven hundred dollars. And I
give unto my son in law Mr Allen Five dollars. I give
to my son in law Charles Torrells one other ninth part
my residuary Estate deducting therefrom five hundred
dollars - I give unto my son Lewis Jones, one other ninth
part of my residuary Estate, deducting therefrom eight
hundred dollars - I give unto my son Thomas Jones, William
Jones, & Samuel Jones, each, one other ninth part of my
residuary Estate. Further my will is that my Negro &
Harry be p'ced under the Guardian of my Executors
