 Last will & Testament in manner and form following
 Item 1st I give and bequeath to my Father my negro
 girl Jane about one year old I give to my Mother
 my negro Woman Mary during her life
 Item 2nd I give and bequeath to my Brother Levi the
 Boring my negro Boy Biko & my negro girl Maria
 Item 3rd I give & bequeath to my sister Ann my negro
 girl Peg upon her Paying to my Executors herein
 after named three Hundred Dollars
 Item 4th I give & bequeath to my sister Malinda my
 negro Boy Ben
 Item 5th I give & bequeath to my sister Matilda my negro
 Boy Levi
 Item 6th I give & bequeath to my brother Michael
 two Hundred Dollars
 Item 7th I give and bequeath to my brother John
 two Hundred Dollars
 Item 8th I give and bequeath to my sister Polly one
 Hundred & fifty Dollars
 Item 9th I give and bequeath to my sister Malinda
 one Hundred Dollars
 Item 10th I give & bequeath to my My nephew Stephen
 Thornton one Hundred Dollars to be Paid in the
 hands of my Executors & put at Discretion until
 he arrives at age
 Item 11th It is my will & Desire that my Executors be
 = but my Effects & Pay of my Debt & the Mortgage
 = giving him in named out of the first Money that
 comes into his hands
 Item 12th It is my Will that my Executors Dispose of
 my Rail Road Stock to the Board of Directors

Item 13th all the Remainder of my Estate both Real and
 Personal not herein specially bequeathed I give
 my Executors to sell on twelve months Credit
 with approved security & the money raised pay
 the Debt of my Property after paying the money
 owing to be Paid divided among the Legates
 herein named Except my nephew Stephen Thornton
 Item 14th I wish my body to be buried in a decent
 & proper manner in the manner and form following
 a house out of Soapstone land over
 Item 15th and lastly I hereby constitute my Brother Levi
 H. Boring Executor to carry into effect this my
 Last will & Testament hereby authorizing all former
 wills which I may have made in testimony
 whereof I have hereunto set my hand & seal this
 9th day of January 1839
