 I have pleased God to bless me with do make my last will & testament in manner & form
 following viz; I leave unto my beloved wife Mary Johnson during her life or widowhood
 my negro man Phillis her child & the use of the house & the choice cow & also
 also my stock of hogs I also will to my said wife during her life or widowhood the
 tract of land whereon I now live the best furniture on which we lie also her
 saddle & all the kitchen utensils & farming tools also my large Bible
 It is also my wish at the death or interment of my wife all the above
 property, the Bible excepted, & which I hereby give to my son Daniel
 Willis, to be equally divided among my six children. I also will that my
 negro woman Rachab be sold at the discretion of my executor
 for the purpose of paying my debts, the balance of the price of her
 to be equally divided among my six children It is further my will
 that my negro girl Nancy remain in my family until my youngest
 daughter shall arrive at the age of twenty one years
 I will to my son Stephen Johnson one bay filly, to my son William
 George one bay filly which came of my blood mare over and
 above an equal dividend of my estate & If there should not be
 a colt taken from my blood for Daniel then he is to have the
 worth of a moderately good horse out of my estate over and above an
 equal dividend, It is my will that all the residue of my estate real
 & personal be equally divided among my six children except
 a deduction of one hundred fifty dollars from the part of Sally
 Trapp as I have given her what I conceive to be worth that sum
 It is also my will that there be a deduction out of my son
 Stephen's part of my estate for whatever myself or executor
 may have to pay for his board while he is the dying medicine
 It is also my will that my executor have leave to sell & convey
 all or any part of my real estate at discretion my wife consenting
 thereto but the proceeds of the land whereon I now live be
 applied to the purchase of another for my wife & subject to
 the same condition as expressed above for this tract
 I testify whereof I subscribe at my house & that this 13th day of
 September 1821, I have made & acknowledged in presence of
 Polly ... & Rachel ...
