It appearing to the Court that James W. Montgomery and John Rogers
Executors of the last will and testament of Benjamin Montgomery late of
this County dec'd both residing in the County of Jasper and State aforesaid

Records of the Court of Ordinary for Jasper County to enable the last named
Court to see that said Estate shall be disposed of pursuant to the provisions
