14th day of November 1856 to us directed, authorizing
us to make a distribution of the Estate of Luke Mc-
Glohorn late of Jefferson County deceased among the
distributtees of said Estate as provided to us by Asa
Holt Guardian of Mary Grier formerly Mary McGlo-
horn and Vandy McGlohorn heirs and distributtees of
Luke McGlohorn Decd. We have this day proceeded to
the performance of said duty and find two distribu-
tees to wit Mary Grier wife of John M. Grier and
formerly Mary McGlohorn and Vandy McGlohorn a mi-
nor whose interest was represented by Asa Holt Guar-
dian of said Minor. The property consisted of the fol-
lowing Negroes viz Ellen a woman, Nancy a Girl, Manah
a Girl, Phil a boy and Alfred a boy. The shares were
numbered 1 and 2, and were assigned to the distributtees
in the following manner to wit:

Lot No. 1. Consisting of
Ellen a woman valued at \$550.00
Nancy a Girl valued at 600.00
and Phil a boy valued at 800.00
making a total value of \$1950.00
all of which is awarded to John M. Grier Fur-
ther for the sole use benefit and behoof of his wife
Mary Grier.
Lot No. 2. Consisting of
Alfred a boy valued at \$1000.00
and Manah a Girl valued at 950.00
making a total value of \$1950.00
which still re-
mains in the hands of Asa Holt Guardian of

We the undersigned four of the partitioners appointed to divide and distribute the Slaves belonging to the Estate of Patrick B. Connolly late of said County deceased, among his heirs at law and distributees, viz Williamina A. Hemmingson (formerly Connolly) widow of said Deceased represented by Thos C. Bell. Bell her Executor under her marriage settlement, on her intermarriage with Charles H. Hemmingson. Thos H. Taylor in right of his wife Mary (formerly Connolly) John Randolph Whitehead in right of his wife Sarah (formerly Connolly) Robert H. Connolly Emma Connolly represented by her Guardian Robert H. Connolly, she being a minor. John Connolly a minor represented by his Guardian Malcolm D. Jones and Malcolm D. Jones administrator of John Connolly, who has departed this life since her father, the said Deceased, having this day met to make partition as appraisers, and after being duly sworn to the faithful discharge of said duty according to law by Sherrod Livingston a Justice of the Inferior Court of said County as appraisers by the certificate thereto attached under the following return of our acts and doings in the premises.

Charles A. Fontaine and Thos C. Bell administrators of said Deceased, having exhibited to us one hundred and thirty two (132) Slaves as the whole number now belonging to said Estate, we appraised them by personal inspection and for their names, and the appraised value of each as per the list hereinafter set forth, as assigned to the several distributees, Evidence being furnished us that the three estates aforesaid had received advancements in Slaves from the Deceased during his life which according to the law of force at the time of the Deceased's death, must be brought into hotch pot, for the benefit of the Children not so advanced, but not for the benefit of the undivided because necessary to separate her portion from
