

William J. Smith's Will.

In the name of God amen - I William J. Smith of the County of Johnson and state of Georgia being of sound and disposing mind and memory and being desirous to settle my worldly affairs while I have strength so to do make and publish this my last will and testament hereby revoking all wills by me at any time heretofore made, and first I command my soul to God who gave it and my body I desire to be buried in a decent and Christian like manner and my worldly estate I dispose of as follows.

- Item 1st & 2. I desire that all my just debts be paid. Second. I give and bequeath to my beloved wife Nancy Smith the tract of land on which my buildings stand containing five hundred acres to have and to hold during her natural life time, at the expiration of which time it shall belong to her children.
3. Third - I desire that all the remainder of my lands be equally divided between my beloved children and when inferior lands fall to one heir let it be made up to that heir from other property or money.
4. Fourth - I desire that my yoke of oxen remain on the premises for the use of the family, and the stock cattle I dispose of as follows. I leave in the care of my beloved wife all my stock cattle for her and her children to support on until the oldest heir is of the age of twenty one years, at which time she shall give him two cows and their calves, and as each heir comes of age or to twenty one years to have a like portion, and in the event that my wife die, then an equal division to be made between all the heirs.
5. Fifth - I leave in the care of my beloved wife my three head of horses and all my hogs and all my sheep with house hold and kitchen furniture with plantation tools and rifle gun and my buggy for the use and benefit of the family during her natural life time, after which time they may be sold and an equal division be made between each heir.
6. Sixth - I desire that my timber wagon and chain belonging thereto be sold and the proceeds to go to use and benefit of the family.
7. Seventh - I desire that my beloved brother George Smith execute this my last will and testament. In witness whereof I the said William J. Smith to this my will consisting of one sheet of paper have set my hand and seal this May 3d 1863.
