By this my last will and testament, I give all my lands negroes and property of every description to my wife Lavinia Hawkins and our daughter Georgia Murkoge Cherokee Carolina and Virginia, and our son Madison and William Hawkins my nephew of North Carolina to be divided in eight equal parts to their heirs forever. If my wife ^{and} or chooses to stay here she can do so with the property or if she should move into Georgia or any state to settle she has full power to do so to purchase a settlement for her convenience and accomodation for her children as her judgment may direct. I appoint my nephew William ^{Hawkins} as guardian for the Education of my son Madison I appoint my wife Lavinia Hawkins executrix and my nephew William Hawkins Executor of this my last will and testament given under my hand at the Creek Agency this ninth day of January one thousand Eight hundred and twelve.

and feeble in body but of sound and disposing memory
do make & decree this my last will and testament
in the manner and form following (viz) I improme-
ise I give to my sister Nancy Bittle and her heirs
or assigns twenty five hundred dollars which is
to be paid out of my crop now growing should it
amount to that sum but if my crop should not amount
to that sum twenty five hundred dollars then it on

to my Brother Nathan Harris and his lawful heirs the sum of one thousand dollars to be paid out of my estate. I then I give and bequeath to my brother Hewitt Harris ten dollars. I then I give and bequeath unto my brother Richard Harris after his paying all my just debts the balance of my estate both real and personal that is to say all my land negroes house hold and kitch furniture and stocks of all kind all of which I give unto him and his heirs forever. Lastly I hereby appoint constitute & ordain my brother Richard Harris and my trusty friend Robert Hutching sole Executors in and of this my last will and testament hereby revoking making null and void all former wills by me before made or made ratified & confirmed this and this only. In testimony whereof I have hereunto set my hand & affixed my seal this eighteenth day of July in the year of our Lord one thousand eight hundred and seventeen. Signed as follows interlined with the word his in the seventh space.
