of Jones State of Georgia Being at this time in a low state of  
health of body but in my common state of mind think proper  
to dispose of all and such property as the Lord has blest me  
with in the following manner to wit

1<sup>st</sup> I confirm the gift of all the property I have heretofore  
given to my son M Satterwhite now in his said M Satter  
white hands

2<sup>nd</sup> I confirm the gift of all the property I have heretofore  
given to my son John now in his said John possession

3<sup>rd</sup> I confirm the gift of all the property I have heretofore  
given to my son Thomas M now in his said Thomas M  
possession

4<sup>th</sup> I give to my son William the Land whereon I now live  
known as Lot No Eighty five in the twelfth District in said  
Jones County with thirty acres more or less apart of Lot No Eighty

six I also confirm the gift to said William two negroes to wit  
Ben + Jane and know more of my Estate hereafter confirm-  
ing the gift to said William other such property heretofore  
given to him.

5<sup>th</sup> I confirm the gift to my son Elijah all the property I have  
heretofore given to him now in the possession of said Elijah

6<sup>th</sup> I confirm the gift to my son Eliza all the property I have  
heretofore given to him now in the possession of said Eliza

7<sup>th</sup> I confirm gift of all the property I have given to my  
daughter Mary that is to wit

nature Cow + calf. I also place in the hands of my Executors hereinafter named a negro girl molly and her increase for the Benefit of said Phanny during Her said Phanny's life not to be sold or disposed of in any way whatever but to be at the command of my said Executors, during said Phanny's life and and her death to be divided between her said Phanny two children.

8<sup>th</sup> I confirm the gift of my Daughter Lucy all the property heretofore given her said Lucy.

9<sup>th</sup> I place in the hands of my Executors hereinafter named three negroes to wit Adam, Eliza + Angelina for the support or Benefit of my Daughter Amy during her said Amy's life remaining in the hands of my said Executors and at their command for said Amy's support not to be sold or disposed of in any way and at said Amy's death the said three negroes Adam, Eliza + Angelina and their increase to be equally divided between said Amy's children confirming the gift of all such property heretofore given to said Amy that is to say a Horse + saddle, cow + calf, Bed + furniture.

10<sup>th</sup> I confirm the gift of all the property heretofore given to my Daughter Susanna now in said Susanna's possession.

11<sup>th</sup> I confirm the gift of all the property heretofore given to my Daughter Patsy now in her said Patsy's possession.

12<sup>th</sup> My will is that all my property not above named consisting of House + Kitchen furniture such of Horses Hogs + Cattle plantation tools Blacksmith's tools my interest or part of a Wagon with my son John four negroes Dick Lot Jincy + Citty a parcel of Land Bought of Daniel Hightower also fifty acres of Land or part of a lot my son Thomas M now lives on a claim for a thousand forty seven acres of land in Colbert County be sold and Equally divided betwixt my children to wit M Lattinwhite, John, Thomas M, Elijah Chiche Phanny, Lucy Amy Susanna, and Patsy the part that will or may come to my two Daughters Phanny + Amy go and remain in the hands of my Executors hereinafter named for the support of said Phanny + Amy as above named in the seventh + ninth items. I constitute + appoint my sons M Lattinwhite + John my Executors and they my last will requiring them to act in the best way they can in answer to this my last will. In testimony whereof I have hereunto set my hand and fixed my seal this

I Dugal McFarlands of the aforesaid state + county being weak of body though of perfect mind + memory knowing that it is appointed for all men to die do make + ordain this my last will + Testament in manner + form following (that is to say) First I recommend my soul to God who gave it + my body I recommend to the Earth from whence it came to be buried at a Christian burial at the discretion of my Executor, and as to such worldly wealth as it has pleased God to bestow on me I give bequeath + dispose of the same as follows

First I give + bequeath to my beloved spouse Catharine McFarlands during her widowhood the lot of land I now live on + six negroes (to wit) Nancy, Joe, Amy, Sams + Jack. With all the increase of said Amy likewise all my stock of horses Cattle Hogs + sheep, my household + kitchen furniture Beds + furniture plantation and farm utensils of every description. I should my wife + myself after my decease I will one of my Executors be child
