The balance of my Estate both real and personal to be sold and equally divided among all my legal heirs. My next desire is that my Son John Jones should act as Executor of this my last Will and testament. Signed Sealed and delivered in the presence of September the 17th A.D. 1827.

In the third place, my request and desire is that Joseph Day Esquire shall act as my sole executor in carrying this my last will and testament into effect.
