queath to my son Job Castleberry one Negroe Woman
named Naney + her two youngest Children, Sandom
and Seaborn. 6.th I give + bequeath to my son Isaac
Castleberry one negroe man named Adam + a Boy
named Jacob. 7.th I give + bequeath to my son in law
Charlton Thompson one negroe man named Toney + a
Negroe Girl named Cherry. 8.th I give + bequeath to
my son Richard Castleberry's heirs fifty dollars to
be paid out of my effects when my Executor has a
Sale + Collects that much money. 9.th I give and bequest
my Son David Castleberry the aforesaid Land whereon I
now live. - I give the above named, properly to my
heirs after the death of my Wife Ammy Castleberry. I
