Rawls, John	76 108-111 08-11-1843 Plaintiff was Rawls. His attorney was firm of Love and Pollhill. Defendants were Joseph Payne and Abraham Shiver. Case was debt of on a \$1100.00 promissory note the defendants made on Nov 26, 1838 and gave to the plaintiff. Judge Carleton B. Cole. Clerk Francis Thomas. Sheriff F. H. Rowe served the papers on the defendants on August 17, 1843. At the March term of court, 1844, the death of the plaintiff was suggested (means he had died) and sci-fa was ordered to issue. On June 24, 1844, Judge Cole ordered that Charles E. Taylor and Caroline Rawls, as administrators of the estate of the deceased John Rawls of Pulaski County, be made parties to the case and that the defendant appear at the next term of Laurens Superior Court. Rawls, John	76 108-111 08-11-1843 (# 2) At the Sept term of 1844, jury verdict awarded to the plaintiffs in the sum of \$106.25 principal, with \$22.66 interest and costs of \$15.37 and 1/2 cents. Fi-fa issued.
Rawls, John	80 7-8 06-00-1840 Plaintiff was Rawls. Defendants were Henry Gibeons and James Lewis. Judgement was for \$45.00. Fi-fa handed to Sheriff Elzy Thompson on Dec. 26, 1839.
Rawls, John	81 1-2 12-26-1839 Plaintiff was Rawls. Defendants were Henry Gobson and James Lewis. Fi-fa was for \$45.00. In June, 1842, Sheriff F. H. Rowe made notation of no property to be found. Fi-fa sent to attorney J. M. Kelly on August 8, 1842.
Rawls, John	81 41-42 09-10-1844 Plaintiffs were Charles E. Taylor and Caroline E. Rawls, administrators of the estate of the deceased John Rawls. Defendant was Joseph Payne. Fi-fa was for \$160.25. \$70.00 paid on the fi-fa on Nov. 5, 1844. \$60.00 paid on the fi-fa on January 11, 1845. The fi-fa was marked settled in full on March 3, 1845.
Ray, James C.	64 37-39 08-13-1847 Ray, of Houston County, gave his \$700.00 promissory note to Olivia C. Woodward of Laurens County. To better secure the note, which was due on December 25, 1848, Ray gave Woodward title to all of his wool carding picker and building on the west end of mill dam of John M. Hampton. If note paid as scheduled, the title to the security would be void. Document was witnessed by Henrietta E. Robinson and Justice of Peace Robert Higdon.
Ray, James C.	64 58-59 08-14-1849 Ray, of Laurens County, gave his \$800.00 promissory note, in 4 payments, to Robert Higdon of Laurens County. To better secure the payment of the note, Ray gave Higdon title to 50 acres whereon is located a mill and wool card factory. If the note was paid as scheduled, the title to the property would be void. Document witnessed by Abraham Lafavor, Wiley Higdon and Justice of Peace Samuel Alligood. (Ray had previously borrowed land on the card from Woodward. This note to Higdon may have been used to pay off the note to Woodward.)
Ray, James C.	72 386-387 02-07-1853 James C. Ray, of Laurens, sold to Hayden Hughes of Laurens. For the price of \$1600.00, land sold was 100 acres. Land District and Land Lot Numbers not stated but was the same land Ray bought from Robert Higdon Sr. Land included a grist mill on Rockey Creek and it ran from below the mill at a ditch, then along a road known as the -----Road to the district line between the 18th L. D. and the 22nd L. D, thence to the NW corner of said lot between lands formerly belonging to John Love, Sr. and said Ray. Deed witnessed by James W. Graves, Robert Higdon and Justice of Peace W. H. Darsey. (Deed appears to be a 100 acres around the grist mill and pond.)
Rayfield, John	72 24-26 01-07-1851 Thomas N. Guyton, Sheriff of Laurens County, sold to Edward Perry. For the price of \$23.50, land sold was Lot # 21 in the town of Dublin. This sheriff sale was the result of a fi-fa issued out of the Laurens County Inferior Court. The deed does not indicate the owner whose property was seized. Deed was witnessed by E. J. Sheftall and Justice of Inferior Court F. H. Rowe.
Rayfield, John	72 196-197 09-11-1852 John Rayfield, Willis Rayfield, Washington Baker and William Pharris, all of Laurens County, sold to James Scarborough of Laurens. For the price of \$500.00, land sold was 1st L. D., L. L. # 225. Deed witnessed by T. N. Guyton and Ordinary F. H. Rowe.
