

Will of Vashiti Lindsey, deceased.

Georgia. In the name of God, Amen.

I, Vashiti Lindsey, being of sound & disposing mind and memory, and desiring to arrange my worldly affairs, while yet healthy & strength sufficient are spared me, do make this my Last Will and Testament, hereby revoking all Wills or dispositions of my property, as heretofore made by me.

Item 1st - I will and bequeath to my three daughters, Falmira Lindsey, Drucilla Lindsey and Francis Lindsey my negro man Cassin, and her daughter Emma, and all my effects and property of every character and description, of which I may be seized and possessed, with the exception of the legacy which is hereinafter specified I leave and bequeath to my son John P. Lindsey the said property so bequeathed to be divided equally between them. Said negroes not to be sold, but

Item 2nd = I give and bequeath to my son John P. Lindsey one cotton bed and bedstead. Item 3rd = I hereby appoint & constitute my son Samuel Lindsey my executor of this my Last Will and Testament. In witness whereof I have hereunto set my hand and affixed my seal, this 14th day of May 1859.
