gity God for the same, do make and Publish, this my  
last will and Testament, in manner and form fol-

Item. after all my just Debts are paid, [which] I do not  
think will exceed the sum of three hundred Dollars.  
It is my will that my executors or Executrix, [as is  
hereafter mentioned], shall receive out of my Estates, ei-  
ther from the rents or Rents of my lands, or from the crops  
or crops, that may arise, from my Riggers, the sum of  
One hundred Dollars, to each of my two Daughters Ann  
Eliza, and Susannah Kent Myers, for the express purpose  
of Advancing their education —

Item. I give to my Dearly beloved wife Eliza beth Myers the  
sum of Ten Dollars in hand of Dower — and all the  
residu of my Estates, both real and personal, I give  
and bequeath unto my wife, and any child, or chil-  
dren she may now be poynant with, and my three  
children, Joseph Hartbury Myers, Ann Eliza Myers &  
Susannah Kent Myers, There are no Share alike —

Item. It is my will that my Son Daniel, until he  
be, [may be bound] to a good master, until the age of Twenty one years, and my Daughters, or Daugh-  
ters, until the age of Eighteen years, and I do make  
by appoint, my Friends, Joseph Hart, & Thomas  
Hill, sole executors, and guardians, to my aforesaid Es-  
tate, and children, to this my last will and Testament,  
hereby revoking all former wills, by me made, — — —

thousand eight hundred and five —
