In the name of God Amen, I Daniel Myers, in aforesaid County & State, being weak in body, but of sound and perfect mind and memory, blessed be Almighty God for the Same, do make and Publish, this my last will and Testament, in manner and form following —

Item after all my Just Debts are paid, [which I do not think will exceed the Sum of Three hundred Dollars] It is my will that my executor or Executors, [as is hereafter mentioned] shall receive out of my Estate, or then from the rents or Rents of my lands, or from the crops or crops, that may arise, from my Negroes, the Sum of One hundred Dollars, to each of my two Daughters Ann Eliza, and Susannah Stent Myers, for the express purpose of advancing their education, —

Item I give to my Dearly beloved wife, Clara both Myers the Sum of Ten Dollars in Lira of Silver — and all the residue of my Estate, both real and personal, I give and bequeath unto my wife, and any Child or Children she may now be pregnant with, and my three children, To wit: Thurbury Myers, Ann Eliza Myers & Susannah Stent Myers, Share and Share alike, —

Item It is my will that my last mentioned Son, Daniel Myers, may be bound out to a good trade, untill the age of Twenty one years — and my Daughters, or Daughters untill the age of Eighteen years, and I do hereby appoint, my Friends, Messrs Joseph Lacey & Thomas Hill, Sole executors, and Guardians, to my aforesaid Estate and Children & to this my last will and Testament, hereby revoking all former wills, by me made, —
