

I Samuel Spencer of the County of Liberty and State of Georgia, Calling to mind the Mortality of my Body and knowing that it is appointed for all men once to die do make this my last Will and Testament in manner and form following
Item, I give and bequeath unto my wife Ann the sum of Five hundred Dollars and her Children to her, her Heirs and assigns and should they not make her equal with my Children of what they shall heir of my personal Estate it is my will that she shall receive as much of my personal Estate as will make her Equal with my Children; And it is also my will that my wife be allowed to live on the Plantation on which I do now reside and to have a proportionable part of Cleared land for her hands to cultivate during her natural life, I also give her my Gold Watch my Riding Chair and One horse at Option, and all that I give her is in lieu of her Dower

Item, It is my will that my sons and Daughters shall share Equally in my Estate both Real and personal which I give unto them their heirs and assigns forever; And it is my will that my sons shall receive their divided of my Estate at the age of Twenty Years and my Daughters at the age of Eighteen or Marriage - And should my wife be pregnant at the time of my decease it is my will that No Child or Children shall share Equally in my Estate with my other Children - I constitute and appoint my Son Joseph Spencer, Joseph Thomas William Norman May, Elias Capelle Thomas Baker Senr. Joseph May Junr. my sons Saml and William Esqrs. and my wife Ann heirs of this my last Will and Testament Authorizing them to act in behalf of my Estate as they shall think most to the Interest of my Heirs
