In the name of God Amen. I Mary Ann Melle, of Liberty County in the State of Georgia, widow of William Thomas Melle, late of Chatham County, deceased, being weak and infirm in bodily health, but of perfect mind and memory, do make and ordain this my last will and testament.

In the first place, as to what worldly estate wherewith it has pleased God to bless me with, after payment of my funeral expences, and all my just and lawful debts, I give, devise, and bequeath, and dispose of the same in the following manner.

Item 1st Last, I give, and bequeath to my daughter Martha Saunders Melle my three negro slaves, Rose, Kelly and Jerry, and the issue & increase of the said female slaves, together with my horse, jig, stock of cattle, sheep, beds and bedding, furniture, jewellery, which I now have, or may be possessed of; at the time of my death. And all the rest, remainder and residue of my estate, of every kind & description, I give, devise and bequeath the said slaves, and their future increase, my horse, jig, stock of cattle, sheep, beds and bedding, furniture, jewellery, and all the rest and residue of my estate, I give - devise and bequeath to my said daughter Martha Saunders Melle, and to her heirs forever. But in case the said Martha Saunders Melle should die before marriage, or without children or issue, of her body living at the time of her death, then and in such case, I give, devise and bequeath the said female slaves, and their future issue and increase, horse, jig, stock of cattle, sheep, beds & bedding, furniture, jewellery, and all the rest and residue of my estate, to my sister Alicea G. Beorie, during her life, and at the death of my said sister, it is my will, and I do hereby give, devise and bequeath the said negro slaves, Rose, Kelly and Jerry, and their future issue and increase, and all the rest, remainder and residue of my estate, of every kind, to John B. Koff, son of my esteemed friend Mrs. Eliza Lamb, of Boyan County, to him and his heirs forever.

Item It is hereby my will, wish, and my express desire, that at and immediately after my death, that my sister Mrs. Alicea G. Beorie should take into her charge and keeping my daughter Martha Saunders Melle; and that she should continue in his charge and keeping until she arrives to the age of eighteen years, or until she is married.

But in case my said sister should die or be disabled in carrying my said daughter to either Glynn or Camden Counties, or in case my said sister should die before my said daughter arrives to the age above stated, then and in either case, it is my express will, wish and desire that my friend Mrs. Eliza Lamb should send for, and take into her charge and keeping, and have the whole control and management, and the bringing up, of my said daughter Martha Sanders Mell, to the time or age above stipulated.

I do hereby appoint Benjamin Lamb, of Bryan County, and William Rose, merchant of Savannah, executors of this my last will & testament.

And I do hereby utterly disallow, annul and revoke all and every other former testament or will, hereby ratifying & confirming this and no other to be my last will and testament.

In witness whereof I have hereunto set my hand and seal, this twenty eighth day of January in the year of our Lord one thousand eight hundred and twenty eight.
