

This Indenture made between Jany Wade Int. of
Wilkes County State of Georgia of the one part and Thomas
Lacey of Lincoln County and State aforesaid of the other part
Witnesseth that the said Thomas Lacey for the consideration
of the sum of one Thousand Dollars paid to me in hand the
Receipt of which is hereby acknowledged before the signing
sealing and delivering of these presents hath bargained and
sold aliened in profit and conveyed and by these presents
doth bargain sell alien in profit convey over to the said
Jany Wade his heirs and assigns all of that certain Tract
of land situate lying and being in the County of Lincoln
on Pistol Creek bounded and joining to and of John Russell
and Jany Mills, Beginning at a Hickory corner N. E. 24 to
a Stake thence S. 20. W. 12. to a Dead oak thence S. 70. E. 23
to a Hickory thence N. 20. E. 23 to a Dead oak thence S. 70.
W. 13 1/2 to a Dead oak thence N. 4 W. 44. to a Hickory thence
S. 70 W. 48. to Dead oak & Willow oak from thence to the drain-
ing or beginning corner joining Benjamin Smith heretofore
containing two hundred Acres more or less and Ninety acres
Joining the said two hundred Acres formerly granted from
William Sims to the said Lacey lying on the said Pistol
Creek joining land formerly John Gambels Deceased
to the west Simons Russell to the South and to the South
to Jared Sudith containing as above wrote Ninety Acres
more or less which makes in the whole two hundred and
Ninety Acres according to a plat annexed to the said
Signed by John Burdick on the 5th of April 1798.
Together with all and singularly the Rights, easements
members and appurtenances therunto belonging or in any
wise appertaining with all remaining Reversionary Rights
Issues and profits thereof To have and to hold all
the said Tract of land unto the said Jany Wade

by His and assigns forever free from all incumbrances
whatsoever and the said Thomas Casey doth hereby covenant
that he is seized and possessed of an Estate in fee simple in the
premises and hath full and ample power to alienate and
convey the said Estate unto the said James Wade by
His and assigns and the said Thomas Casey for himself
by His Executor or administrator, will warrant and
forever defend the said Parcel, a Tract of &c and against
himself by His Executor and administrator and all
manner of persons whatsoever unto the only proper use
and behoof of the said James Wade by His Executor
Administrator or assigns forever in witness whereof
the said Thomas Casey has hereunto set his hand and
affixed his Seal the twentieth day of February
Eighteen hundred and nine.
