do constitute and ordain this to be my last Will and Testament
first. I will all that my Just debts be paid.

2nd Item. I have given and delivered into possession to my
son David Bupoy all his part of my Estate except one Shilling
Sterling which is to be raised out of my Estate to him and
his heirs and assigns:

Item. I have given and delivered to my daughter Elizabeth
Edwards all her part of my Estate. except one Shilling Sterling
which is to be raised out of my Estate to her and her heirs and
assigns forever.

Item. I do give and bequeath to my son Benjamin Bupoy
one feather bed and two Cows and Calves which is to be
sold out of my Estate to him and his heirs forever.

Item. I do lend to my loving wife during her life the
Tract of land I now live on containing two hundred
acres with three negroes viz. Hall, Sacked Hannah with all
of my Stock of horses & Cattle and Hogs. together with all
the house hold furniture and Plantation tools for the
benefit of raising and Educating of my small Chil-
dren, Heskiah Bupoy. Nathan Bupoy. Rebecca Bupoy
Nancy Bupoy. Amy Bupoy. Lucracy Bupoy. which
estate is to be kept together during my wife's widowhood
and if she marry a new inventory of all to be taken

Item. I do will that my Executors give nothing into
hands of any other person without good security
save my wife's part.

Item I will that the land I now live on be eq-
divided between my son Heskiah & Nathan Bupoy
to them and their heirs forever.

After the death of my wife. I do will after the de-
ath of my wife Amy all the Estate left her be equally
divided amongst my six last Children. Which are
Nathan, Rebecca, Nancy, Amy, Lucracy & Heskiah
their heirs & assigns

only I do ordain my loving wife Amy Executrix and my son David Bupry & John Edwards Executors of this my last will and testament.
