In the name of God Amen I Samuel Hammons of the County of Lincoln and State of Georgia being weak in body but in my right mind senses and memory do make and appoint this my last will and testament in manner and form following disavowing and revoking all other wills and testaments heretofore made and first I bequeath my soul to god that gave it Through the merits of Jesus Christ my redeemer And I commit my body to the earth to be decently buried at the discretion of my executors hereafter named and I rely I give and bequeath to my beloved wife Elizabeth thirty acres of land adjoining William Hammons line in dividing the house and spring with wife the

house hold for nature. also my loved one during
his natural life or widowhood after words to be equally
divided between ^{amongst} my three children.

and 4^{thly} The remainder of my land to be equally divid-
ed between my three children that is to say my son
~~Thomas~~ ^{John} Hammons and my son John Hammons and
my daughter Susannah Hammons.

and 5^{thly}. such property as can be spared from the
family use to be sold to pay the loss of the land
and the schooling of my children.

and 6^{thly} That the three children rest of my property
be equally divided between my three children when
they shall come of age

and 7^{thly} that I make and appoint my father John
Hammons dec. & my brother William Hammons Ex-
-cutors of this my last will and testament
