

Will of Thomas Fox

State of Georgia
Lowndes County

In the name of God amen.

I, Thomas Fox of said State and County being of advanced age, and knowing that I must shortly depart this life, deem it right and proper to do respects my family and myself that I should make a disposition of the property which a kind providence has blessed me, do therefore make this my last will and testament hereby revoking all others heretofore made by me

Item 1st

I desire and direct that my body be buried in a decent, Christian like manner suitable to my circumstances and condition in life. My soul I trust shall return to our Father God who gave it, as I hope for eternal salvation through the merits and atonement of the blessed Lord and Saviour Jesus Christ, whose religion I have professed and I humbly trust enjoyed for a number of years.

Item 2nd

I desire and direct that all my just debts be paid without delay, by my Executors hereinafter named appointed as I am unwilling my Creditors should be delayed in their rights.

Item 3rd

I give and bequeath to my beloved wife Mary E. Fox all of my property consisting of real and personal property during her natural life, said property consisting of four hundred and eighty eight (488) acrs. of lot of land number four hundred and twenty four (424), one hundred and thirty five acrs. of lot of land number four hundred and five (405), both of said lots of land in the Eleventh (11th) District of said County, also lot of land number three hundred and fifty seven (357) in the Seventh (7th) District of Clinch County Ga. and lot of land number ninety (98) in the twelfth (12th) District of Clinch County Ga. Also two head of mules, one horse, twenty head of stock Cattle and forty head of hogs, all of my farming utensils consisting of Plows, Plow gear, hoes, axes, and every thing I now own and possess on the place; said property to belong to her during her natural life and if she should die suddenly I then direct that my friend James F. Wall take charge of all of said property and manage the same for the benefit of my children by her, share and share alike.

Item 4th

I hereby constitute and appoint my beloved wife Mary E. Fox Executor and my esteemed and worthy friend James F. Wall Executor of this my last will and testament.
