In the name of God, Amen

I George H. Buchanan of the county and a State aforesaid being in full health but of sound and disposing mind and memory do make publish and declare this to be my last will and Testament in manner and form following.

I commit my soul into the hands of him from whom I received it - hoping that when it shall have left this mortal it will be taken home to Heaven. My body I wish decently buried by the side of my departed companions. As to such property as it has pleased a kind and merciful Providence to make me steward over I dispose of in the following manner.

I wish my just debts paid and leave it discretionarily with my Executor to use such of my property as he may think best for this purpose unto my surviving Residue Arzina. I give and

and a devise the following named negroes Sarah and her two children, Nestley & Mastings, unto my son in law Robert Hutton & give grant and devise the following named negroes Mary & Bose, unto my son in law George Godfrey, & give grant, and devise the following named negroes, John & Shebe unto my son in law Thomas Cockerell & give grant and devise one negro named Dick and lot of land (M^o) ninety six in the (30) thirtieth district of (originally) Lee now Marion County it being the land upon which I now live, unto my son in law George Cockerell, & give grant and devise the sum of five dollars this amount to be his full share and legacy from my Estate, as to the rest and residue of my property both real and personal it is my will, wish and desire that it be sold, and the proceeds be equally divided between the aforesaid Reuben, Alzimir Robert Hutton George Godfrey, Thomas Cockerell share and share alike, I hereby nominate and appoint my son in law George Godfrey Executor to this my last Will and Testament, and I hereby revoke and annul and every Will or Wills by me at at any time time heretofore made, and sign, seal publish and deliver this to be my last Will and Testament, in witness whereof I the said George H. Buckhannon have hereunto set my hand and seal this twenty third day of June 1845
