Bertha to have all the land between the Road leading to Stewarts Corner and the Ellaville and Tazewell road with the use of half of gin house as now used by her and half interest in the pasture as now fixed with the corner to be at the spring at South West of pasture. These lands to be for said Bertha and her bodily heirs, Edgar to have a life time interest.

I will to Willie Pool and her bodily heirs half interest in the pasture mentioned in Bertha's interest and the lands West of Ellaville Road and South of the pasture with corner at spring running due south west to line between Dr. Murray and myself, Uchee Creek being the South line. ~~These lands to have a life time interest~~

The balance of my property not willed I leave for my wife Arrie Hogg to will as she wishes as I believe she will be fair with her people and mine and do what is right about it. At any time through life any parties interested shall take to drink or other immoral habits their interest shall cease. If my wife survives me I want her as soon as convenient I want her to sell off my personal property.
