March 17-1834 to Malcolm McDonald.

Meriwether County } This indenture made the 7 day
of March in the year of
our Lord eighteen hundred and thirty four
between Thornton Holmon of the one part and
Malcolm McDonald of the other part both of
the state and County above written. Witnesseth
That the said Thornton Holmon for and in con-
sideration of one hundred dollars to him
in hand well and truly paid by the said Malcolm
McDonald at or before the sealing and delivery
of these presents the receipt whereof is hereby
acknowledged have granted bargained sold
conveyed & confirmed and by these presents
do grant bargain sell release convey & confirm
unto the said Malcolm McDonald his heirs
and assigns all their part of a lot of
land that shall contain the west half of lot
No fifty one in the Eleventh District of
Meriwether formerly Group County & to the
one hundred one and one fourth Acre be
the same more or less to gether with all and
singular the rights Members and appurtenances
agreeable to a bond binding said Holmon
to make title to the said west half of said
lot as above written to the before named Malcolm
McDonald his heirs and assigns for ever
and against the claim of said Holmon his
heirs and assigns and also against the
claim of any other person or persons
whatsoever. Shall and will warrant and

for ever defend by their presents

Georgia } This indenture made this
Muskegee County } the twenty first day of
February in the year eighteen hundred and
thirty seven Between Benjamin Drew
and William Drew Silas Easters and Patrick
Price the first of said County and state the
others of the Territory of Florida. And George W.
Chatfield of the County of Meriwether and state
of Georgia of the other part Witnesseth that
the said Benjamin Drew William Drew Silas
Easters & Patrick Price have for and in con-
sideration of the sum of two hundred
and fifty dollars Granted bargained sold &
Conveyed and do by their presents grant
bargain sell and Convey to the said George
W. Chatfield his heirs and assigns all of
of Land number twelve in the seventh
district of formerly Group now Meriwether
County to have and to hold the said lot of Land
situated as aforesaid to the said George W. Chat-
field his heirs and assigns to his and their
own proper benefit & behoof forever in
fee simple. And the said Benjamin Drew
William Drew Silas Easters & Patrick Price
will each and all jointly and severally warrant
and forever defend the right and title for
the said Land for themselves and their heirs
to the said George W. Chatfield his heirs and
assigns forever
