

Georgia, Meriwether County.

I, Wm.R.Faver, being of advanced age but of sound and disposing mind and memory, knowing that I must shortly depart this life, make this my last will and Testament, hereby revoking and annulling all others by me heretofore made.

ITEM First : I give, bequeath and devise to my wife, Sarah Faver, during her natural life or widowhood, the following property to-wit: Fifty acres of land in the 8th dist of said county, and in the South east corner of Lot of Land No. 100, said dist. I also give, bequeath and devise to my said wife Sarah Faver the sum of Two Hundred dollars, which said land and money, I intend to be in lieu of dower and Year's support, the two hundred dollars if free from all charge or limitation whatever

ITEM SECOND: I give, bequeath and devise to Mrs. E.M. Faver, the wife of my son A.C. Faver, for and during her natural life, the following property, to-wit : East half of lot No. 99, Ninety nine, in the 8th dist of Meriwether County including and embracing the improvements on said Lot No. 99, and if in the division of said Lot No. 99, the east half of said lot does not embrace or take in the improvements, then I intend and direct that enough more of said lot be added to the east half of same, to embrace the house and improvements, and I leave it to my executor hereinafter appointed, to run the line in such manner as he may deem best, and from which there shall be no appeal.

ITEM THIRD: I give, bequeath and devise to my son, A.C. Faver for and during his natural life, the following property, to-wit: Fifty acres of land in the Northwest corner of lot of land No. 99, ninety-nine, in the 8th dist of Meriwether County. Remainder to his children, (my grand children) and if any of said children be dead leaving child or children, such child or children shall take such interest as their father or mother would take or have taken. (GAr)

ITEM FOURTH: I give, bequeath and devise to my grandchildren, children of my son A.C. Faver, the remainder of my estate (share and share alike) including the remainder in the land, devised to my wife in Item first of this my last will and testament, and if any of said children be dead leaving child or children, such child or children shall be entitled to such interest as his, her or their father or mother would have taken.

ITEM FIFTH: I hereby constitute and appoint my friend, B.F. McLaughlin Executor of this my last will and testament.
