

Will of William Rogers.

In the Name of God Amen. I William Rogers of the County of Milton and State of Georgia being of sound Mind and Memory, and considering the uncertainty of this frail and transitory life do therefore make, declare, publish and declare this to be my last will and testament; that is to say,

First, After all My just debts, (New or old) are paid and discharged, the residue of My estate real and personal, I give and bequeath and dispose of as follows, to wit: to My beloved wife and to our beloved daughters Sarah S. Moore and Mary Amelia and to our beloved son Augustus S. Rogers, and to My two grand Children in Arkansas, the Children of My son Henry S. Rogers, (They Claiming as one) all My homestead place (what I have given away excepted) known as Oakland, to be divided equally between them share and share alike, I have some wild lands in the Mountains of Pickens County, which together with My Stock and all perishable property, may be sold, and the proceeds arising from said sale and all the Cash I have on hand to be divided amongst all My Children share and share alike.

I will and bequeath all My household and kitchen furniture to My beloved wife. For making My will My only wish is to do equal justice to all My Children and to My wife - If upon the settlement of My estate My executors herein after named, should see that I have failed in this the darling object of My heart, they will so change My distribution as to accomplish this object. They know what they have received themselves and what they have received outside of My will. All of which they will take into

likewise I make, constitute and appoint my son
Robert N. Rogers and my son in law Anderson S.
Bell to be executors of this my last will and testament
hereby revoking all former wills by me made.

and sixty eight.
