 - 3 " 3 I give bequeath & devise to my twin daughters Sarah Hudlow & Elisabeth Bennett my stock in the agusta Gas company amounting to Ten hundred & fifty dollars to be divided equally among the two
 - 4 " 4 I give bequeath & devise to my grand daughter Elisabeth Underwood the following property to wit one hundred dollars now held by her father John L Underwood for which I now hold his note also my bed bureau & washet and now in possession of her mother Amy Currie Underwood
 - 5 " 5 I give bequeath & devise to my son Joel Warren Currie all my cattle in decator County Ga and my gold spectacles
 - 6 " 6 I give bequeath & devise to my grand daughter Emily Lacy Currie all my cattle and intrest in Baker County Ga
