Dasher or any for and has obtained temporary letters of Administration of the Goods & Chattels Rights & Credits of S W Howard deceased promisor of the above bound E W Howard shall lawfully collect & preserve from waste or loss all the Goods & Chattels and effects of the said S W Howard and shall make or cause to be made a true & perfect Inventory of all such estate and the same being so preserved do surrender up such estate and with the Inventory of the said estate to the legal & proper Administrator on or by the first Monday in November next - or so soon thereafter as the Court shall direct with all his other actings and writings therein that this obligation to be void otherwise to remain in full force in law
