 tion of the sum of three thousand dollars to me in hand paid at and before the
 sealing and delivery of these presents, the receipt whereof is hereby acknowledged
 hath this day bargained, sold, given, delivered unto Harrison Calpelier of the aforesaid
 State and county all that tract or parcel of land lying and being situate in the
 county of Monroe in the thirteenth district thereof known and distinguished in the
 plan of said district by the number (258) two hundred and fifty eight containing
 two hundred two and one half acres more or less also a certain tract or parcel of
 lands containing one hundred one and one fourth acres lying and being in the 18th
 district of the aforesaid county known by the east half of lot 10 253 adjoining lot
 253. The said Harrison Calpelier to have and to hold with all and singular
 the rights, tenures, fees and profits thereto belonging or in any wise appertaining
 to the said premises unto him his heirs and assigns forever
 and I the said Eli B. Browning, do hereby warrant and will forever defend the
 title to the said bargained premises to the said Harrison Calpelier his heirs and assigns
 against the claim or claims of myself, my heirs, executors or any and
 every other person whatsoever in fee simple forever

 the receipt whereof the said Davis Smith doth hereby acknowledge hath this day
 bargained and sold and do by these presents bargain, all convey and confirm unto the
 said Orlando Holland his heirs and assigns all that tract or lot of land situate, lying
 and being in State & county aforesaid known by the number thirty three in the
 eleventh district of said county containing two hundred two and a half acres
