in the words following I leave to my beloved wife Sally
Fulder all my Estate both Real & Personal for the proper
use & benefit of herself & my Children and at the expiration
of the life or widowhood of my wife Sally Fulder I
with all my Estate both Real & Personal not herein mentioned
to be sold & an Equal Division made amongst all my Children
I leave it discretionary with my Executors to make a division
at the coming of age of my youngest Daughter Emily Fulder
if by consent of my wife Sally Fulder but not without
her consent in case a Division should take place before the
expiration of the life or widowhood of my wife Sally
Fulder then I leave her a sufficient maintenance
out of my Estate during the above mentioned term to be
excluded from said division till the expiration of her
life or widowhood & then to be equally divided among
all my Children my will is at the coming of age of my son
Abraham Fulder that my Executors give to him one horse saddle
& bridle one cow & calf one feather bed & furniture & at the
coming of age of my son Thos Fulder Billy Fulder
Sally Fulder Moriah Fulder & Emily Fulder I leave
each of them as they severally come of age one horse saddle
& bridle one cow & calf & one feather bed & furniture of the
value thereof at the discretion of my Executors & my
wife Sally Fulder but at the expiration of the life or
widowhood of my wife Sally Fulder or should she
consent to a division then my will is that all my Estate
both Real & Personal not here before mentioned to be equally
divided amongst my then surviving Children except such
as have deceased & left lawful heirs or heirs of their
body & in that case such heirs or heirs shall receive
their deceased Parents Part of my Estate and should any
of my Children die without a lawful heir
of their body then their Part of my Estate shall be

Equally divided amongst my then surviving
Children which is as follows to wit William S. Fulmer
Thomas Fulmer Polly Fier John Fier Obadiah H. B.
Josiah Fier Isaac Fier Jennell Fier Betty Fier
Sally Fier James Moriah Fier & Tempy Fier as
hereby appointed executors William S. Fier & Obadiah H. B.
Fulmer my lawful Executors to this my last will
& testament Signed Sealed & acknowledged this 18th day of
