5th I will to my son Thomas, all my riding apparel
 of whatever kind I possess & thirty dollars cash, he
 being blind said thirty dollars being a part of
 a note I hold on R. McCumby.

6th I will to my son Jeremiah, a note of hand
 on him for five dollars Also I will to my said
 son Thomas an obligation I hold on my son Samuel
 & Harrison for fifty dollars it being a part of the price
 of a piece of land, except so much as he is entitled to
 by my will is. that each of my children, shall have one dollar
 apiece out of said fifty dollars, provided they are each of
 them.

7th I will to my son in law, E. H. Harrington the
 following things to wit one iron cage one pair
 of plow harness, harness & chains & collar on, riding
 saddle & bridle & all my axes, except one axe which
 I want, my wife Nancy to have, I hold two notes
 one on W. H. McCoy and one on John Dill, which
 I desire to be collected, and paid over to Robert
 L. Smith, towards paying him for his share, I owe
 him. I hereby appoint my friend
 Robert W. McCoy my sole Executor of this
