

State of Georgia Muscogee County

I, Samuel B. Wamock being of sound and disposing mind and memory, but having in view the uncertainty of life do make, ordain and publish this my last will and testament

Item 1st I give and bequeath unto my brother James T. Wamock Fifty Thousand Dollars of Bonds to be selected by him from all my Bonds, and to be estimated at the par value of the same, to be held by him in trust as follows.

First. To use the interest arising from the same, or so much thereof as he may deem expedient, for the support and maintenance and education of the children of my deceased Sister Maria McLeod until the same shall be distributed as herein after provided.

Second. When each of said children shall arrive at the age of twenty one, then the said bonds, and any accumulations of the interest on the same shall be divided into as many parts as there shall be of said children then living; and pay over one part thereof to such of said children as may then arrive at said age.

Third. In case any of said children shall marry before arriving at said age; then in the discretion of said Trustee such child shall receive its part of said Bonds, & accumulations of interest.

Fourth. If any of said children should so marry, and die leaving a child or children, before arriving at said age, and without receiving a portion of said Bonds, then the child or children so left, to stand in the place of the parents and to receive a share, which may be paid by said Trustee to any legal Guardian of said child or children upon the death of the parent.

Item 2^d I give and bequeath to the said James T. Wamock the further sum of Eight Thousand Dollars of Bonds to be selected by him after the first amount, and estimated in like manner, to have and to hold in trust for the support, maintenance and comfort of my Mother during her life; and at her death then to be divided between my heirs per Stirpes.

Item 3^d Whereas, I have heretofore purchased a certain Stone House and lot in the City of Columbus Georgia, and now occupied by A. M. Brannon as a Drug Store; and have caused the title to be made to my Sister Sarah E. Wamock; I do declare the same to have been a gift to her and do hereby ratify and confirm the same. I do further give and bequeath unto my said Sister Eight Thous and dollars of Bonds, to be selected after the first two lots and estimated in like manner. To have and to hold, to her forever, in fee simple.

Item 4th I give and bequeath unto John W. Frazer as Superintendent of the Sunday School of the 1st Presbyterian Church of Columbus Five Hundred dollars of Bonds. To have and to hold unto him

and to his successors as such Superintendents, to loan and employ the interest of the same in the purchase of Books & Bibles to be presented to such of the children of said Sunday School, as shall recite the shorter Catechism in our lessons, and if the whole of the interest is not needed for such purpose, the balance to be used in the purchase of Books for said Sunday School

Item 5th If it should so happen that there should not be a sufficient amount of Bonds left by me to carry out the foregoing bequests; then I direct my Executor in Georgia to purchase enough for such purpose, of such Bonds as may be preferred by those to whom they are to be given; provided they shall cost no more than the average market value of such as I may be and

Item 6th I do further give and bequeath all the remainder of my Estate both real and personal, both in Georgia and Alabama to be equally divided between my Brother James T. Hamock, and my Sister Margaret A. Bethune; the share of my said Sister to be held by her as her separate Estate —

Item 7th I appoint my Brother James T. Hamock as Executor of this my will in the State of Alabama, and I do empower him to sell any part of my estate either real or personal in said State either at public or private sale, as he may deem best for the purpose of carrying out the provisions of this will; and I further desire that he shall not be required to give any bond either as such Executor, or as Trustee as herein mentioned

I further appoint William L. Galisbury to be Executor in Georgia and give him the same power and privileges as is given to my Executor in Alabama; and I do direct that he shall transfer all my personal property, and pay over the proceeds of my Real Estate or personal property, which may be sold or converted into money, to my said Executor in Alabama, and that my entire estate shall be distributed by my said Brother —

But if my said Brother should not be such Executor, then the same be distributed by my Executor in Georgia
