 On this 15th day of November 1866 in vacation comes Alfred Swerson & Wiley Williams who being sworn on oath say that they were present when John Fontaine then in life but now deceased executed the foregoing instrument in writing that at the time of executing it he published and declared it to be his last will and testament that he signed the same in the presence of deponents and B Beasley who at his request signed their names as witnesses thereto in presence of said Fontaine & of each other And deponents further say that afterwards to wit on the day of the date thereof said Fontaine executed in like manner his Codicil to said will published declared and signed as aforesaid in presence of deponents and Harvey Hall who subscribed their names (at the request of said Fontaine) thereto as witnesses in his presence and in presence of each other

Deponents further say that at the time of executing said written instruments said Fontaine was of sound and disposing mind and memory and that so far as witnesses know or believe he did it freely of his own accord without any undue influence or compulsion

Wm H Griswold's Will
 In the name of God, Amen
 I William H Griswold of the State of Georgia and County of Muscogee being of sound and disposing mind and memory and being desirous to settle my worldly affairs while I have strength to do so do make and publish this my last will and testament: And first I commit my soul to God who gave it

and my worldly estate I dispose of as follows
 Item first It is my will and desire that my son shall proceed at once after my decease to sell and dispose of all my effects except such as may be desirable to give to my son Harry as he makes such sale to be either public or private and without any order from the Ordinary as my Executor may deem proper and that he shall collect such sums as may be due upon the Policies of Insurance of my life which may be outstanding and out of the proceeds he shall immediately pay all my just debts

Item second All that remains after the payment of my debts I give to my son Harry to be paid to him upon his arriving at the age of twenty one years or at the discretion of my Executor when he has obtained a good substantial education embracing a full course in some good mercantile college or school

Item third I desire that the legacy to my son shall remain in the hands of my Executor to be invested by him in some farm where it will be safe and pay a good interest If the interest should exceed the outlay for the use of my son then the excess to be likewise invested

Item fourth I constitute Dr S T Andrews and his daughter Helen as guardians of the person of my said son and direct my Executor to pay over to them or either of them semi annually an amount sufficient for the support maintenance and education of my said son out of the legacy before mentioned

Item fifth I have directed the actuary of the Insurance Company to change the Policy so as to make the sum insured payable to my legal representatives I do this in order that there may be no question of the right of my Executor to pay my debts out of this fund but in case it is not so changed then I appoint William H Brannon (my Executor) to be guardian of the property and estate of my son and authorize and direct him to pay my debts of this fund when collected by him as such Guardian knowing that my said son would never receive any legacy or benefit through me until all my debts were paid

Item sixth I hereby constitute and appoint my friend William H Brannon to be my Executor and desire that he should not give any Bond for the performance of the trust hereby reposed in him
