Baker of the County of Newton & State of
Georgia being of sound disposing mind & memory and being
desirous of disposing of my property in my own way - do
hereby certify publish & declare the following to be my
last will & testament - Hereby revoking all other wills
made or to be hereafter at any time.

Item the first - It is my will and direction that
all my just debts be paid & as early after my
death as it can be conveniently done.

Item the second - I do hereby give & bequeath to my
wife all & singular the property of every nature & kind
whatsoever brought by her in into the settlement and
this in lieu of dower in any of my lands.

Item the third - It is my will & desire that after
my death my executor proceed as early as practicable to
sell all my real estate lying & being in Newton County
and in other places if any, also all my personal estate
of every nature & kind whatsoever except my negro prop-
erty and the fund owing from such sale to be
equally divided share & share alike between accounting
for any advancement made, between the following persons
viz Daniel Jackson father my son, Jesse L. Baker my
son, Thomas Baker my son, Isaac L. Baker and Daniel
J. Baker in trust for my son Wiley Baker & his children
Jesse L. Baker & Daniel J. Baker in trust for my son
Gadrick L. Baker & his children. To my son in law
Charles Hudson, and to Jesse L. Baker & Charles J. Baker
in trust for the life & separate use of remnant of my
daughter Elizabeth Hudson & her children; to my daughter
Mary Nelson, son John Nelson & my daughter Jefferia
Hoff & her heirs and to my daughter Alice Parley & her
heirs - making in all ten shares to which the same is sub-
ject to division.

Item the fourth - It is my will and desire that my
executor procure three persons to be appointed by the Court
of Chancery of Newton County, to divide my negro property
into ten shares and the same after after such division to
be given to the two persons provided for & placed to in

the third & pecuniary item of this my will, and the shares in-
tended for my daughter Elizabeth Hudson & my sons Wiley &
Gadrick be held by the said Jesse L. Baker & Daniel J. Baker
in trust respectively for them.

Item the fifth - It is my will and desire that all other property
possessions of debt & not herein before disposed of be my executor turn
over to the two persons upon to in the third item & upon
the terms & manner therein provided for.

Item the sixth - It is my will & desire that my wife have
in other share or interest whatsoever in my estate either real or
personal or mixed other than is given to her in the second
item of this will.

Item the seventh - It is intended that this last will &
testament is to embrace any and all property moved & disposed
by me at my death either not herein named or may result
from future acquisitions or from the income of any

Item the eighth - Having full faith & confidence in my
sons Jesse L. Baker & Daniel J. Baker I do hereby appoint them
executors to this my last will and testament. In witness

October Eighteen Hundred & forty seven.
