Lane, and all parties above named announcing ready et vir, That Mrs. A. C. Lane, and all parties above named announcing ready et vir, Don Wright and Mrs. Lula T. Lane, and all parties above named announcing ready et vir, That Mrs. A. C. Lane, wife of B. T. Lane, died in Wichita Falls, Texas, April 23, 1925. That B. T. Lane and Mrs. A. C. TESTIMONY OF MRS. ELLA SIMONDS.

No. 1048  
In re; Heirship of B. T. Lane { In the County Court of

Be it remembered that in the above cause the following evidence was introduced at the hearing, being the testimony of the witness Mrs. Ella Simond:

Q: Your name is Mrs. Ella Simond? A: Yes, sir.  
Q: You live in Wichita Falls, Texas? A: Yes, sir.  
Q: B. T. Lane was your father and Mrs. A. C. Lane was your mother? A: Yes, sir.  
Q: When did your mother Mrs. A. C. Lane, die? A: She died April 23, 1925.  
Q: When did your father, B. T. Lane, die? A: The 13th of August, 1926.  
Q: Had either your father or mother ever been married before they married each other? A: No, sir.  
Q: Were either of them ever married to any one else? A: No, sir.  
Q: Did either of them leave a will? A: No, sir.  
Q: Have the children made diligent search among the effects of them both and failed to find a will? A: Yes, sir.  
Q: Did they leave an estate - property? A: Yes, sir.  
Q: Did they leave a house and lot at 1009 - 15th St.? A: Yes, sir.  
Q: Did they leave a house and lot at 1506 Elizabeth Street? A: Yes, sir.  
Q: Did they have a savings account in the City National Bank of Wichita Falls, Texas? A: Yes, sir.  
Q: About how much? A: About \$7,000.00.  
Q: Did your father leave a checking account in the City National Bank? A: Yes, sir.  
Q: About how much? A: About \$230.07.  
Q: Did he leave a safety deposit box in the City National Bank? A: Yes, sir.  
Q: Have you searched that box and failed to find a will? A: Yes, sir.  
Q: You don't know the nature of the papers that are in that box do you?  
A: No, sir.

Question by Judge Nicholson:  
Q: Do you mean to say that you do not know whether there is a will in the papers or not?  
A: We have looked through the papers and know there is no will in them.

Direct Testimony resumed:

Q: Did some of your brothers with an officer of the bank open the box to determine whether there was a will in there or not? A: Yes, sir.  
Q: Now how many children were born of the marriage of B. T. Lane and Mrs. A. C. Lane? A: Seven.  
Q: Name them. A: J. T. Lane, J. W. Lane, Mollie Lane, Ella Lane, W. I. Lane, R. K. Lane, C. W. Lane.  
Q: No other children were ever born to the marriage? A: No, sir.  
Q: You are now married and your husband's name is Henry Simond? A: Henry Simond, yes, sir.  
Q: Mollie Lane, is she living? A: No, sir.  
Q: In her life time to whom was she married? A: Edwin Abbott.  
Q: Her name then at the time of her death was Mollie Abbott? A: Yes, sir.  
Q: Is J. W. Lane alive? A: No, sir.  
Q: When did he die? A: He died in October, 1918.  
Q: How many children did he have? A: I will name them all: Lloyd Lane, N. H. Lane, Orine Lane, Lulia Lane, Beulah Lane, Flora Lane, Pauline Lane and J. T. Lane.  
Q: Those are the eight children? A: Yes, sir.  
Q: Now Orine, is she living? A: Yes, sir.  
Q: Is she married? A: Yes, sir.  
Q: What is her husband's name? A: Mrs Lewis.  
Q: Is Julia married? A: Yes, sir.  
Q: What is her husband's name? A: Otis Alexander.  
Q: Is J. T. Lane living? A: Yes, sir.  
Q: Is Beulah Lane living? A: Yes, sir.  
Q: Is Flora Lane living? A: Yes, sir.  
Q: Has she ever married? A: No, sir.
