Permelia Elizabeth Lane, Eliza Davis, Nancy Carrie Collins and Judith (J.E.) Butler of Paulding County of the first part. George W. Lane of the County of Paulding the second part. Witnessed that the said parties of the first part, for and in consideration of one hundred and fifty dollars in hand paid at or before the reading and deliver of these presents, the receipt wherein is hereby acknowledged. Have granted, bargained, sold and conveyed unto th party of the second part, his heirs and assigns that tract or parcel of land knowned as the James C. Lane mill and gin. Lying and being in the northeastern part of land lot # 438 in the 2nd Dist and 3rd Section of the said County. Having satuated here-in one steam cotton gin, mill and all of the fixtures being of the following dimensions to wit: Northside one hundred and fifty (150) feet long, Eastside one hundred and twenty (120) feet long, Northside one hundred and twenty (120) feet. Westside one hundred and thirty-five (135) feet long. Containing two-fifths of an acre more or less.
