

WILL OF MRS. MAGGIE S. BASSETT

Georgia, Peach County.

I, Maggie S. Bassett, of said State and County, being of sound and disposing mind and memory, do make this my last will and testament, hereby revoking and annulling others by me heretofore made.

Item 1.

I desire and direct that my body be buried in a decent and Christianlike manner, suitable to my circumstances and condition in life.

Item 2.

I desire and direct that all my just debts be paid without unnecessary delay by my Executors hereinafter named and appointed.

Item 3.

I give, bequeath and devise to my daughters Bertha Bassett Matthews and Nanine Bassett all of my property, both realty and personalty, wherever situated, absolutely in fee simple, share and share alike. It is my will and desire, however, that should either of my daughters die without child or children surviving them, the portion of my estate in possession and control of the daughter at the time of her death shall go to and be the property of the surviving daughter.

Item 4.

I appoint Bertha Bassett Matthews and Nanine Bassett, my daughters herein mentioned, Executors of this my last will and testament and empower them to sell any part of my property, at public or private sale, for my consideration which their judgment may dictate. I further empower them to borrow money, securing same by any of the property of my estate as their judgment may dictate. I relieve my Executors from making any bond, agreement or returns to any Court whatsoever.
