

Georgia, Houston County.

I, Jno F. Troutman, of said State and County, do hereby make this my last will and testament revoking hereby all other wills heretofore made by me.

Item 1st. I desire and direct that all my debts be paid as soon after my death as the same can be conveniently done and without waiting for the customary twelve months to elapse.

Item 2nd. I give, bequeath and devise to my beloved wife Cordelia P. Troutman my entire estate real, personal and mixed, except the two legacies given below to my two grandsons; the property given to my said wife is intended to include everything, whatever may be its character or kind; and is to belong to her absolutely in fee simple, to be used and disposed of entirely at her discretion. I leave it entirely to her own good pleasure to provide for my two younger sons, Claude H. and Hoo F. Troutman as she may wish and may deem best; my elder son James H. Troutman, I have already assisted and aided as fully as I should, and it is my ~~express~~ express request that my wife shall not further aid or provide for him.

Item 3rd. I give and bequeath to my grandson Bradford Troutman, son of the said James H. Troutman, ten shares of stock in the American Building and Loan Association of Minneapolis, Minnesota.

Item 4th. I give and bequeath to my grandson Holmes Troutman also son of James H., Ten shares of stock in the Interstate Building and Loan Association of Columbus Ga.

Item 5th. I hereby appoint my said wife, Cordelia P. Troutman, the Executrix of this my will, and I desire and direct that she give no bond, make no inventory or appraisement of the Estate, make no returns, and that immediately upon her proving this will and qualifying as Executrix that she have and exercise the fullest possible power over the entire estate, sell or dispose of it at public or private sale or in any manner that to her seems best and my wish being to rest in her both in paying my debts and in her own enjoyment of the property the widest possible liberty she may ~~xxx~~ require or desire.

In the name of God, Amen.

I, Cordelia P. Troutman, of Fort Valley, Houston County, Georgia, realizing the uncertainty of life, and being of sound and disposing mind and memory, do make, declare and publish this my last will and testament, hereby revoking all wills and codicils to the same heretofore at any time made by me.

Item First.

I desire that all my just debts be paid, and a suitable monument erected over my grave as soon after my death as practicable.

Item Second.

I give, bequeath and devise to Claudia Troutman, Wynton Troutman, and Julia Troutman, Junior, children of my son Claude H. Troutman, the sum of five hundred dollars each. And if at the time of my death either of said children should be deceased, the survivor or survivors, shall take the share of their deceased brother or sister. And if at the time of my death none of said children

shall be in life, the money hereby given in this item shall be given to and become the property of my son John F. Troutman.

Item Third.

Having heretofore given to my granddaughter Dedie Troutman, what I consider to be her full share of my estate, I give her nothing more in this will. I give, bequeath and devise to Bradford L. Troutman, and Holmes F. Troutman, the sum of One hundred dollars each. And if at the time of my death either of said children shall be deceased, the survivor shall take the share of the deceased brother. And if at the time of my death none of said children shall be in life, the money given in this item shall be given to and become the property of my son John F. Troutman.

Item Fourth.

I hereby give to my son John F. Troutman all the household and kitchen furniture, including crockery ware, china, silverware, library &c.

Item Fifth.

I give, bequeath and devise all the residue of my property, both real and personal, not heretofore given in this will, to Mrs. John F. Troutman, her son Frank Troutman, share and share alike.

Item Sixth.

I nominate and appoint my son John F. Troutman, Executor of this my last will and testament, and hereby relieve my Executor from making annual returns or any appraisement of my estate, and hereby fully authorize my said Executor to sell any of the property both real and personal, which I may die seized and possessed, at private or public sale without order from any court having jurisdiction to give the same, and that upon approving this my last will my Executor shall execute the same, file proper receipts from the legatees in this will and be discharged.
