WILL OF MARTHA DAVIS WILSON

GEORGIA, PEACH COUNTY.

I, Mrs. Martha Davis Wilson, of said state and county, being of sound and disposing mind and memory, do make this my last will and testament, hereby revoking and annulling all others by me heretofore made.

1.

I desire and direct that my body be buried in a decent and Christian-like manner suitable to my circumstances and condition in life.

2.

I desire and direct that all my just debts be paid without unnecessary delay, by my executor hereinafter named and appointed.

3.

I give, bequeath and devise to my children, Wayne Davis Wilson and Martha Frances Wilson, that tract parcel of land of mine consisting of 75 acres, more or less, in Peach County, Georgia, near Fort Valley and lying on the Taylor Mill road, my son Wayne Davis Wilson, to have the North portion of said tract of land, and my daughter, Martha Frances Wilson, the South portion, this to be arrived at by a line running through the place East and West, thus making an equal division thereof, said lands to be theirs absolutely and in fee simple for ever.

4.

I have already heretofore given my son, Wayne Davis Wilson, his part of the furniture that I had and I now will, bequeath and devise all furniture that I may have at the time of my death to my daughter, Martha Frances Wilson.

5.

I will, bequeath and devise all other property that I may have, both real and personal,

to my children Wayne Davis Wilson and Martha Frances Wilson, share and share alike the equal division of same.

I hereby name and appoint my husband, E. F. Wilson, as executor of this will, to expressly relieve him of making any inventory or appraisement of my estate, or from his bond or making any returns to any court, and he is requested only by this will to probate the will.

This 24th day of July, 1928.

Signed, sealed, declared and published by Mrs. Martha Davis Wilson as her last will and testament, in the presence of the undersigned as witnesses thereto, being called individuals especially by Mr. Martha Davis Wilson as witnesses to this will, she first signing the same in our presence, and we then signing as witnesses in her presence and in the presence of each other; This 24th day of July 1928.

In the name of God, amen.

I, Mrs. Sarah Elizabeth Dasher, of Fort Valley, Georgia, being of sound and disposing mind and memory, do hereby make, publish, and declare this to be my Last Will and Testament, hereby expressly and specifically revoking the two wills heretofore made by me, and now and nullifying any and all wills I may have heretofore made.

ITEM 1.

I commend my immortal spirit to my heavenly Father, who gave it, and direct that my body be interred in the Fort Valley cemetery, in Peach County, Georgia, on the family where other members of my family have been buried.

ITEM 2.

It is my desire and I direct that Joseph Lee Betts, my grandson, be paid the sum of two-thousand dollars, before any further division of my Estate is made, from any cash personal property of which I may be seized and possessed at the time of my death. But if there is not sufficient money and personal property in my estate after paying the sum of my last illness and funeral expenses, then, and in that event, this legacy cannot be wholly received by the said Joseph Lee Betts, but he shall have and receive any and all monies and personal property of less value than two-thousand dollars that I may be seized and possessed of at the time of my death. Should my personal property and money at the time of my death, after first paying expenses hereinabove referred to, exceed the amount of two-thousand dollars herein bequeathed to my grandson, Joseph Lee Betts, then and in that event, success over and above the two-thousand dollars herein bequeathed to said Joseph Lee Betts shall be equally divided between him, the said Joseph Lee Betts and Mrs. Ellen Dasher, in the event that I should outlive the said Joseph Lee Betts, or Ellen Dasher, their lawful heirs of either or both legatees hereinabove named, to-wit: Joseph Lee Betts and Ellen Dasher shall inherit, have and receive under the terms of this will, per stirpes in share that such deceased parent would have received, if living.

ITEM 3.

It is my Will, and I hereby give and bequeath to my grandson, Joseph Lee Betts, the half of lots of land number 238 and 243 in the ninth District of Peach County, formerly Houston County, Georgia, and in the event that I should outlive my said grandson Joseph Lee Betts, then his legal heirs shall have and receive the portion of my estate herein bequeathed to him, share and share alike. It being understood that twenty acres have been sold off
