I Isaac Mullinas of Said County being of Sound mind
and Senesable of the Mortality of all men and being by
the Mercy of God of Sound Mental faculty and disposing
Mind and Memory though advanced in years Do make
Ordain and declare the following as my last will and
Testament

Item 1st I Commit my Spirit to God who gave it trusting
in his grace and Mercy. And I request my body to receive
a Christian burial Item 2nd I give and bequeath to my
belovd Wife Rachel all my estate real and personal after the
payment of my Just debts during her natural life I kept
back parts thereof as she may request my Executors herein after
named to Sell and dispose of the proceeds to be divided
Among my Legatus hereinafter named for portion to them Several
and under this will in my estate Item 3rd at the death
of my Wife Rachel I wish all my estate both real and
Personal to be divided in to four Equal Shares except as
hereinafter Specified which I will as follows I give
to my Son Bronson Mullinas One Share to my Daughter
Hannah Blaylock wife of David R Blaylock to her and her
Heirs Provided She is in life at the time of my Death
One Share, but if She Should then die then I give
that Share to her Sole heirs of her own body.

To my Daughter Pelley Mass wife of Marasmus Mass One Share
provided She is in life at the time of my death but if She
Should then be dead then I give Said Share to her Equal
Heirs of her own body, To my Daughter Sarah the
widow of Mr St West One Share except as hereinafter
provided To my Son John Mullinas The Sum of Twelve
Dollars if in life at the time of my death but if he
Should then be dead then I give the Said amt to his
Legal Heirs the Said Amount of Twelve Dollars
As above Specified which I wish to be

taken out of the last Share mentioned to Sarah West To my grand Daughters Rachel & Sarah Jane Mullinat The heirs of my son William M Mullinat descent the same of ten Dollars each the said amounts to also be taken out of the last Share mentioned to Sarah West

Item 3rd Having up to this present date given to my children and their heirs their portion in Shares of my said estate there is to be no reckoning or bringing in to hatch for any advancements up to the time made to any of my children or heirs but it is my will that each Share of my estate be ~~distributed~~ distributed as above specified Item 6th

I hereby appoint my Good Menimond Miss and John H. Foreman my Executors of this my last will and Testament and earnestly request them both to accept the office in testimony whereof I have hereunto set my hand and affix my Seal this 11th day of June 1872 Isaac Mullinat
